#### 1. Qualification of the Vendor

The Firms are required to submit the following documents with their proposals.

# 3. METHOD OF PROCUREMENT

will be a "Single Stage – One Envelope Bidding" procedure.

# 4. SCOPE OF SUPPLY

The bidder shall supply items as per specifications given in the attached Annexure-I.

# **5. CURRENCIES OF BID**

The prices shall be quoted in Pakistani Rupees.

# 6. EARNEST MONEY:

The bidders shall furnish, as part of his bid, earnest money equal to 2% of total quoted prices with their offer in the form of demand draft/pay order in favor of **GIK Institute, Topi**. The earnest money shall be denominated in Pak rupees and shall be in the form Demand Draft / Pay Order

issued by a Pakistani scheduled Bank. The Earnest Money may be forfeited if a bidder withdraws his bid during the period of his bid vali<u>d</u>ity or failed to fulfill the contract agreement / PO.
