

DEED OF AGREEMENT
FOR UNDERTAKING A TRAINING PROGRAMME (GA PhD)
AT GHULAM ISHAQ KHAN INSTITUTE OF ENGINEERING SCIENCES AND TECHNOLOGY, TOPI

This Deed of Agreement arrived on between
Mr/Ms..... S/o-D/o
Resident of:..... and Ghulam Ishaq Khan Institute, Topi through the
Rector or on his behalf by a duly authorized representative, hereinafter referred to as Fellow
and Grantor consecutively, witnesses the performance of the following acts:

Whereas the Fellow has been selected for the grant of **PhD** program at the Ghulam Ishaq Khan (GIK) Institute, Topi, on the terms hereinafter mentioned, the same duly acknowledged by the Fellow and in return to it, the sureties of the Fellow have scribed a separate bond, (duly attested by a Magistrate 1st class / Civil Judge 1st class / District Nazim) to indemnify the guarantor.

That unless otherwise, specifically given in the terms of the contract this covenant shall bind the heirs, executors, administrators and assignees of the Fellow.

The Deed further covenants as follows:

1. That as Fellow agrees that after the completion of the course at the Institute shall be bound to serve the GIK Institute, if required by the Institute, for a period of **five years**, and during this period shall not be eligible to enter into any employment with any organization or department (public/private) whatsoever without the prior approval of the Rector, GIK Institute.
2. The Rector of the Institute as of right shall expel the Fellow in the following cases;
 - i. Fails in the courses
 - ii. His/her performance is not up to the mark (minimum CGPA 3.00 each academic year)
 - iii. He/she comes short of 75% attendance
 - iv. He/she is indulged in any activities that are detrimental or prejudicial to the business or character or reputation of the Institute.
3. The expulsion of the Fellow on the grounds stipulated in clause-2 above shall make him/her liable to refund to the Institute, the amount of monthly stipend paid to him/her, irrespective of the tenure the Fellow was on roll, prior to his/her expulsion.
4. No suit or other proceedings criminal or civil shall be taken by or on behalf of the Fellow or their heirs, executors or administrators hereto against the Institute under the said Deed Agreement in respect of above orders of expulsion of the Rector, GIK Institute as per (clause-3).
5. In case the Fellow leaves the course prematurely without any valid reason to the satisfaction of the Rector after getting registered, he/she shall be liable to pay to the Institute full fee for the duration of his/her enrollment upto the end of that academic year at the rate of fee applicable to the course in addition to refund of the amount of monthly stipend paid to him/her. Income tax (WH tax), if due, shall additionally be payable as per law, else he/she shall be liable to serve the Institute as per standard applicable at the Institute for the corresponding duration in lieu of the above amount with remuneration. In addition he/she shall be debarred for any future admission at the GIK Institute.

6. In case the Fellow after completion of the course, fails to fully subscribe to condition No. 1 of this deed, he/she, shall pay to the Institute the tuition fee applicable for his/her total tenure of **PhD** in addition to the amount of monthly stipend paid to him/her and income tax (WH tax), if due, or such a sum the Rector may decide and the verdict of the Rector to the effect shall be final, unquestioned in any court of law.
7. This Deed shall not preclude the Rector of the Institute from the enforcement of any other remedy which in his opinion is invited for application against the Fellow / Surety under the aforesaid agreement.

It is hereby further agreed and declared that in case of the default by the Fellow, to fulfill any of the term of the deed as may be binding under the covenant the grantor/Institute may forth with enforce against the said property, or any part thereof, all or any of the remedies under the law against the surety or his annexed property.
