TERMS AND CONDITIONS

1. Qualification of the Vendor

The following Firms/Suppliers are eligible to apply and required to submit the following documents with their proposals.

6. Technical Staff details
7. The Firms/Supplier that have Never been blacklisted by any Government Agency or Authority.
8. Warranty / Guarantee Certificate

2. GENERAL

- i. Sealed Bids must be accompanied by bid security at 2% of Total Bidder's Price in form of Demand Draft / Pay Order in Original in the name of GIK Institute of Engineering Sciences & Technology, Topi.
- ii. Conditional/incomplete tenders will be not accepted.
- iii. Work to be completed in all respect as per requirements.
- iv. Bidders are encouraged to visit the site to carefully assess the scope of work before submission of bids.
- v. Telephone/telexed/faxed/telegraphic quotations will not be entertained.
- vi. Bids submitted without prescribed Tender fee and Earnest Money shall be liable for rejection at the time of Tender opening. Tender fee in shape of DD/Pay Order and Earnest money shall be submitted separately along with Tender. Cheque is not acceptable.
- vii. Bidders are required to include all applicable taxes in their prices/rates as per rules.
- viii. For Loading, unloading and transportation will be the supplier responsibility.
- ix. Amount should be filled in figures as well as in words and should be in accordance with the general directions given in tender documents. Overwriting and cutting will not be acceptable.
- x. GIK Institute reserves the right to accept/reject any/all tenders/bids as per rules.
- xi. GIK Institute also reserves the right to cancel the order / Contract in case of late deliveries and vendor will be blacklisted as per procedure.

3. METHOD OF PROCUREMENT

Bidding will be conducted through “**Open Competitive Bidding**” process and bidding is open to all eligible bidders that meet the minimum qualification criteria and required documents. It will be a “**Single Stage – One Envelope Bidding**” procedure.

4. SCOPE OF WORK

The bidder shall complete the work as per scope of work given in the **attached Annexure-I**.

5. CURRENCIES OF BID

The prices shall be quoted in Pakistani Rupees.

6. EARNEST MONEY:

The bidders shall furnish, as part of his bid, earnest money equal to 2% of total quoted prices with their offer in the form of demand draft/pay order in favor of **GIK Institute, Topi**. The earnest money shall be denominated in Pak rupees and shall be in the form Demand Draft / Pay Order issued by a Pakistani scheduled Bank. The Earnest Money may be forfeited if a bidder withdraws his bid during the period of his bid validity or failed to fulfill the contract agreement / PO.

7. LATE BIDS

Any bid received by the Purchaser after the prescribed deadline for submission of bids shall be returned unopened to the bidder.

9. PURCHASER'S RIGHT TO ACCEPT OR REJECT ANY OR ALL BIDS:

The GIK Institute reserves the right to reduce or increase the quantity, accept or reject any/all tenders/ bids as per rules.

10. CONVINCING

Unsolicited advice/clarification and any personal approaches at any stage of Evaluations are strictly prohibited and may lead to disqualification.

11. DELIVERY OF ITEMS

The bidder shall make delivery of goods at his own cost within the specified period from the date of issuance of work order from the GIK Institute. In case of delay in work within stipulated time, penalty will be imposed as per following schedule or order may be cancelled. The completion work will be made as per below table after issuance of order (without penalty) or as agreed.

The contract will be awarded to the lowest responsive bid keeping in mind the quality and specifications provided in the bidding document.

14. Taxes: All Government Taxes i.e. Income Tax, GST etc. will be deducted.

Sub: Work for Supply, Fixing, Testing and Commissioning of Rising Main to
Connect the 03-Tube Wells with Main Water Tank

1. Our complete water supply layout at GIK, whether distribution or rising mains has to be replaced, having outlived its stipulated life. There is a dire need to upgrade the system. Existing GI and MS pipes are considered obsolete as more efficient and cost effective pipes are in use now. High density poly ethylene (HDPE) is being extensively used for new as well as replacement piping works throughout the world. HDPE pipes have long term service life, resistance to corrosion, abrasion and chemicals. These pipes are strong, durable, flexible and light weight and give significant overall cost saving.

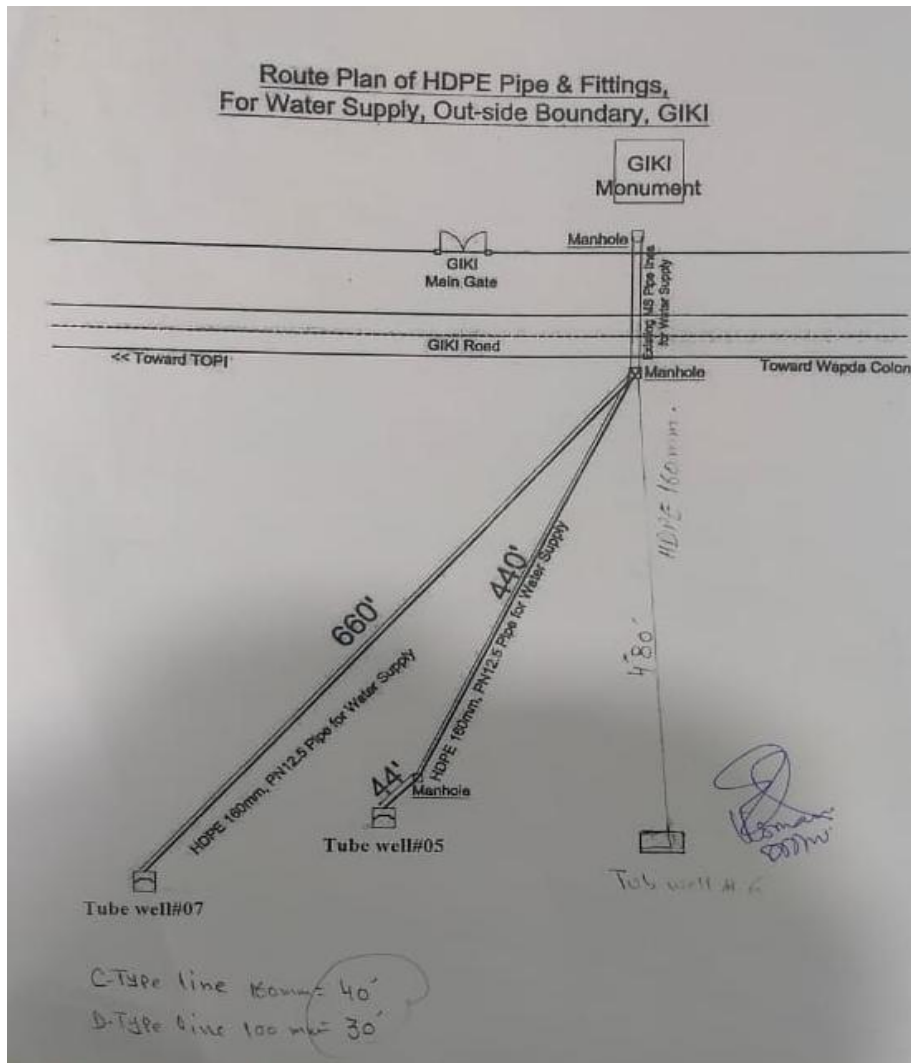
