### <u>TERMS AND CONDITIONS FOR HIRING OF EVENT MANAGEMENT COMPANY FOR</u> <u>INDUSTRIAL OPEN HOUSE & CAREER FAIR 2022</u>

## 1. Eligibility / Qualification of the Vendor

The following firms are eligible to apply for the tender:

- 1. The bidders should be registered with provincial & federal tax authorities and who are on Active Taxpayer List of the revenue authority.
- 2. The Firms that have Never been blacklisted by any Government Agency or Authority.
- 3. Bidders must be experienced in event management and submit previous clients' work orders with proposals.

### 2. Documents Required

Sealed bids are invited from reputed registered Firms/Suppliers and are required to submit the following documents with their bidding proposal:

- 1. Tender Fee along with 2% earnest money.
- 2. Valid registration documents with Taxation Authorities. NTN/FTN/STRN/KPRA etc.
- 3. Active Taxpayer List/Certificate
- 4. Full Address and Contact Numbers of the Office(s).
- 5. Relevant Experience of the bidder
- 6. Submit work orders of previous clients.
- 7. Volume of previous work executed in last three years.

### 3. GENERAL

i. Sealed Bids must be accompanied by bid security at 2% of Total Bidder's Price in form of

Call Deposit Receipt (CDR) in Original in the name of GIK Institute of Engineering Sciences & Technology, Topi.

- ii. Conditional/incomplete tenders will not be accepted.
- iii. Telephone/telexed/faxed/telegraphic quotations will not be entertained.
- iv. Bids submitted without prescribed Tender fee and Earnest Money shall be liable for rejection at the time of Tender opening. Tender fee in shape of DD/Pay Order and Earnest money in shape of CDR shall be submitted separately along with Tender and cheque is not acceptable.
- v. Bidders are required to include all the taxes in their prices/rates.
- vi. For Loading, unloading and transportation charges will be borne by the supplier. No extra charges will be provided.
- vii. Rate and amount should be filled in figures as well as in words and should be in accordance with the general directions given in tender documents. Overwriting and cutting will not be acceptable.
- viii. GIK Institute reserves the right to accept/reject any/all tenders/bids with or without assigning any reason at any stage prior to the award of contract.



#### 4. METHOD OF PROCUREMENT

Bidding will be conducted through "**Open Competitive Bidding**" process and bidding is open to all eligible bidders that meet the minimum qualification criteria and required documents. It will be a "**Single Stage – One Envelope Bidding**" procedure.

#### 5. SCOPE OF SUPPLY

The bidder shall supply items of the specifications given in the attached Annexure-A.

#### 6. CURRENCIES OF BID

The prices shall be quoted in Pakistani Rupees.

#### 7. EARNEST MONEY

The bidders shall furnish, as part of their bid, earnest money equal to 2% of total quoted prices with their offer in the form of demand draft/pay order in favor of **GIK Institute, Topi**. The earnest money shall be denominated in Pak rupees and shall be in the form Call Deposit issued by a Pakistani scheduled Bank. The Earnest Money may be forfeited if a bidder withdraws his bid during the period of his bid validity.

#### 8. LATE BIDS

Any bid received by the Purchaser after the prescribed deadline for submission of bids shall be returned un-opened to the bidder.

#### 9. PURCHASER'S RIGHT TO ACCEPT OR REJECT ANY OR ALL BIDS:

The GIK Institute reserves the right to reduce or increase the quantity, accept or reject any/all tenders/ bids as per rules.

#### **10. CONVINCING**

Unsolicited advice/clarification and any personal approaches at any stage of Evaluations are strictly prohibited and may lead to disqualification.

#### **11. DELIVERY/INSTALLATION OF STALLS:**

The bidder shall make delivery and installation of stalls complete in all respect at his own cost within the specified period from the date of issuance of Work Order from the GIK Institute. In case of a delay in supply within the stipulated time then a penalty will be imposed as per requirement. The work will be completed before the Industrial Open House Event date <u>9<sup>th</sup> & 10<sup>th</sup> May, 2023</u>, otherwise bids will be rejected.
