TERMS AND CONDITIONS

1. Qualification of the Vendor

Firms/ Suppliers / Authorized Distributors or Dealers are eligible to submit proposals who meet below criteria and have following documents:

1. Valid Tax registration certificate NTN/FTN/STRN / KPRA etc.
2. Certificate of Active Taxpayer List
3. Full Address and Contact Numbers of the Office(s).
4. Experience with documentary proof.
5. The Firms/Supplier/contractor that have Never been blacklisted by any Government Agency or Authority.
6. Authorization Letter, if any.
7. Guarantee / Warrantee Certificate.
8. Bid Security 2%.

2. GENERAL

- i. Sealed Bids must be accompanied by bid security at 2% of Total Bid Price in form of Call Deposit Receipt (CDR) in Original in the name of GIK Institute of Engineering Sciences & Technology, Topi.
- ii. Conditional/incomplete tenders will not be accepted.
- iii. Telephone/telexed/faxed/telegraphic quotations will not be entertained.
- iv. Bids submitted without prescribed Tender fee and Earnest Money shall be liable for rejection at the time of Tender opening. Tender fee in shape of DD/Pay Order and Earnest money in shape of CDR shall be submitted separately along with Tender. The cheque is not acceptable.
- v. Bidders are required to include all the taxes in their prices/rates separately.
- vi. For Loading, unloading and transportation charge of the item's supplier will be responsible.
- vii. Items' rates and amount should be filled in figures as well as in words and should be in accordance with the general directions given in tender documents. Overwriting and cutting will not be acceptable.
- viii. GIK Institute reserves the right to cancel PO/ Contract in case of late deliveries.

3. METHOD OF PROCUREMENT

Bidding will be conducted through “**Open Competitive Bidding**” process and bidding is open to all eligible bidders that meet the minimum qualification criteria and required documents. It will be a “**Single Stage – One Envelope Bidding**” procedure.

4. SCOPE OF SUPPLY

The bidder shall complete delivery / supply as per specifications given in the **attached Annexure-I**.

5. CURRENCIES OF BID

The prices shall be quoted in Pakistani Rupees Including all taxes and duties.

6. BID BONDS/EARNEST MONEY

The bidders shall furnish, as part of their bid, earnest money equal to 2% of total quoted prices with their offer in the form of Call Deposit Receipt in favor of **GIK Institute, Topi**. The earnest money shall be denominated in Pak rupees and shall be in the form Call Deposit issued by a Pakistani scheduled Bank. The Earnest Money may be forfeited if a bidder withdraws his bid during the period of his bid validity.

8. LATE BIDS

Any bid received by the Purchaser after the prescribed deadline for submission of bids shall be returned unopened to the bidder.

9. PURCHASER'S RIGHT TO ACCEPT OR REJECT ANY OR ALL BIDS:

The GIK Institute reserves the right to reduce or increase the quantity, accept or reject any/all tenders/ bids as per rules.

10. CONVINCING

Unsolicited advice/clarification and any personal approaches at any stage of Evaluations are strictly prohibited and may lead to disqualification.

11. DELIVERY OF ITEMS

The bidder shall complete supply at his own cost within the specified period from the date of issuance of Purchase Order from the GIK Institute. In case of delay in delivery within the stipulated time then penalty will be imposed. The order will be completed as per below table after issuance of purchase order (without penalty) or as agreed and with the prescribed penalty as per following schedule of requirement: -

12. MODE OF PAYMENT

Payment will be made after complete delivery subject to inspection of equipment and deduction of taxes as per Govt law.

13. AWARD OF CONTRACT:

The contract will be awarded to lowest evaluated bid who meet the specifications provided in the bidding documents.

14. Taxes: All Government Taxes i.e. Income Tax, GST etc. will be deducted.

15. Bid Validity

All offers shall remain valid for 60 days from the date of opening of bids, until any further extension required by the GIK Institute.
